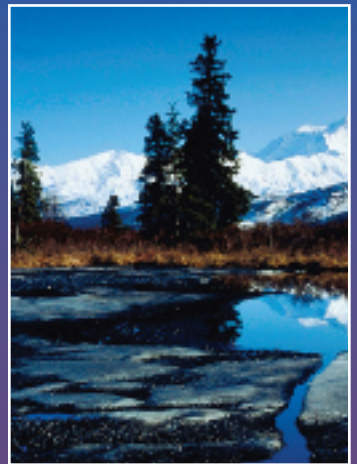

General Information

Course Description

Diagnostic Imaging in Alaska is a postgraduate course designed to update the diagnostic radiologist in new trends, relevant techniques, and advanced applications in diagnostic imaging. The latest advances will be emphasized and related to common problems encountered in clinical practice. A variety of didactic lectures and accessible faculty members will enhance learning throughout the week. Each morning, interesting case of the week presentations from the Mayo Clinic files will be presented in an “unknown case” format. The participant will have these cases and answers to take with them at the end of the week. All faculty members are in practice at Mayo Clinic Rochester, Jacksonville, or Scottsdale and will draw from personal research activities as well as clinical experience at Mayo Clinic.

Course Learning Objectives

Upon conclusion of this course, the participant should be able to:

- Recognize CT and MR imaging features of intra- and extra-axial CNS neoplasms, posterior fossa tumors, lymphoma and demyelating diseases
- Identify MR imaging techniques for the acquisition and interpretation of MRCP imaging
- Review the elements of a successful body MR protocol
- Recognize imaging features of adnexal masses on ultrasound and MR imaging
- Recognize imaging features that identify inconsequential, incidental skeletal MR imaging findings
- Identify appropriate injection and aspiration techniques for commonly evaluated joints
- Recognize techniques for the biopsy of musculoskeletal lesions
- Recognize methods to optimize breast imaging
- Define the use of MR imaging in the evaluation of breast lesions
- Identify imaging features of vasculitis and visceral ischemia
- Identify imaging techniques for nonobstetric imaging of the pregnant patient
- Recognize current nuclear medicine techniques to diagnose infection
- Identify MR imaging features of cirrhosis and focal liver masses
- Recognize MR and ultrasound imaging features of normal variants in the female pelvis

The Itinerary:

The Hubbard Glacier itinerary explores the best of Alaska's coast including steep-walled fjords, abundant wildlife and rustic ports with unique charm. The Hubbard Glacier is visited and provides guests the opportunity to view one of the largest and most active glaciers in Alaska.

Ports of Call:

Seattle, Washington

From its early days as a lumbering center, Seattle has evolved into an exciting and progressive metropolitan area. The soul of the city resides in its downtown area where modern museums and landmarks are interspersed with historic areas, markets, espresso stands, and shopping and entertainment districts.

Sitka

The scenic borough of Juneau covers 3,108 square miles of towering mountains, islands, saltwater bays, forested valleys and residential flatlands.
