USPHS Recommendations

- Exceptions
 - Medication Contraindications
 - Specific Populations (adolescents, pregnant smokers, lights smokers, smokeless tobacco users)



 Ability to employ this knowledge and insight to communicate cross-culturally




Becoming Culturally Competent
